
# 1. Introduction



Global perspectives on social security inclusion for Gig economy participants: In September 2021, in Singapore, the Advisory Committee on Platform Workers was set up to provide adequate financial protection for workers who face any work injury during their work and other retirement benefits [5]. The city govt said that they would introduce injury insurance and pension coverage to the delivery and ride-hailing people from 2024 onwards. In Asia, the government is putting more emphasison platform companies to provide workers with safety and protection [6]. Malaysian Govt, the National Forum, the Gig Industry Career Framework, held on 17 July 2023, is a positive step in bringing together gig activists and platform providers to discuss mutual responsibilities in looking after the welfare of both parties [7]. During the second tabling of Budget 2024 on 13.10.2023, the Malaysian government reaffirmed its commitment to enhancing the welfare of gig workers by addressing initiatives designed to expand the social protection afforded to gig workers [8].

**1.3.** Indian perspective on social security inclusion for Gig economy participants: In July, Rajasthan passed a bill to levy an additional fee on internet transactions on platforms such as Amazon, Zomato, and Urban Company. The aim is to offer financial advantages to gig

workers, marking the inception of such a program in India [9]. Similar initiatives are also underway in states like Karnataka and Tamil Nadu, focusing on extending benefits, formalizing registration for gig workers, and addressing their concerns. According to the Ministry Of Human Resources, the gig industry has huge potential and needs attention and support. Therefore, gigworkers need to be given appropriate social support. Through Act 789, the government hasimplemented a social security mechanism that includes gig workers by launching the Skim Keselamatan Sosial Pekerjaan Sendiri (SKSPS) through PERKESO. In addition, the ministryis drafting a specific guideline for gig operators (p-hailing) and platform provider companies that includes six (6) main elements, which are income, social protection, awareness on aspectsof occupational safety and health, freedom of work, speech and negotiation, training and guidance for career advancement and turnover mechanisms [10].

**1.4. Code on Social Security Bill:** The Social Security Bill of 2020 extends benefits such as maternity support, life and disability insurance, pension plans, provident funds, and employment injury coverage to platform workers. While these workers are now eligible for these benefits, their provision is not assured. The bill allows the Central government to introduce welfare schemes addressing personal and workplace security concerns periodically, but these benefits are not guaranteed. The central government, platform aggregators, and workers share the responsibility for implementing these basic welfare measures [11]. However, the bill does not specify which stakeholder is accountable for providing a specific level of welfare benefits. Ninelaborlaws relating to social security are now inone integrated code.

1.5. Registraion on e Shram portal: The Ministry of Labour& Employment has launched the eShram portal to form a comprehensive national database for workers in the unorganized sectors, integrating Aadhaar's information. This initiative aims to enhance the employability prospects of these workers and facilitate the extension of social security benefits to them. The eshram portal represents the inaugural nationwide effort to compile information on unorganized workers. Spearheaded by the Central Government, this portal is a centralized repository of unorganized workers linked to Aadhaar credentials. Upon registration, individuals become eligible for a 2 Lakh of accidental insurance coverage in the Pradhan Mantri Suraksha Bima Yojana (PMSBY) in the future, all the social security benefits for unorganized employees will be maintained through this portal. In times of emergencies and crises like nationalones, such as pandemics, this database can be utilized to assist.







Furthermore, it will serve as the primary platform for disbursing social security benefits as coordinated by both Central and State Ministries [12].

#### 2. Literature Review


